RE: **Revised NIGP Code Exempt List** 

The Department of Administrative Services (DOAS) State Purchasing Division (SPD) announces publication of a revised and updated NIGP<sup>1</sup> Code Exempt List effective December 9, 2025. The NIGP Code Exempt List is an informational resource to assist state entities in documenting exempt purchases as required by the Georgia Procurement Manual (GPM). Key revisions to the NIGP Code Exempt List are summarized below.

**IMPORTANT:** All state procurement professionals must carefully review GPM Section 1.2. "Determining Application of this Manual: Is the Good/Service Exempt?" for an overview of exemptions from DOAS' competitive bidding rules. As a reminder, the fact that a purchase may be exempt from the State Purchasing Act is not a representation that other laws may not apply or that the purchase may not need to be competitively bid. SPD strongly encourages state entities to make all purchases as competitive as possible.

- 1. **Utility Services** (Except when Customer Choice). The following two NIGP Codes have been added to the NIGP Exempt List: (a) 96183 Electrical Utility Services and (b) 96184 Gas Utility Services. Previously, NIGP utilized a single code (96185) to identify electric, gas, and water utility services. In 2016, NIGP separated the different utility services into three individual codes. At the time, SPD's NIGP Code Exempt list was updated to retain code 96185 and its revised description, but SPD unintentionally failed to add the two other codes to retain the original intent of exempting all utility services except when customer choice is available within the location. **REMINDER:** All state entities must utilize the mandatory statewide contract for natural gas (Contract #99999-001-SPD0000192).
- 2. Foster Care Services. For use by the Department of Human Services (DHS) only, NIGP Code 95247 Foster Care Services has been added to the NIGP Code Exempt List. Official Code of Georgia Annotated (O.C.G.A.) Section 50-5-69(f) authorizes DHS, through its Division of Family and Children Services, to contract for the placements of children in the state's care or custody without competitive bidding.

- 3. **Accounting, Auditing, Budget Consulting Services.** For NIGP Code 91804, Accounting, Auditing, Budget Consulting, the explanatory note has been revised to further clarify application of the exemption.
- 4. **Live Animals**. NIGP Code 04022 Chicks, Meat Type, Baby has been added to the NIGP Code Exempt List. This code is related to the exemption when purchasing livestock for slaughter.
- 5. **Fresh Bakery Products**. NIGP Code 37552 Pies has been added to the NIGP Code Exempt List. This code is related to the exemption when purchasing perishable/fresh bakery products.
- Art Objects. The following NIGP Codes related to the purchase of original artwork have been added to the NIGP Code Exempt List: (a) 05250 Murals, (b) 05251 Murals, Clay, (c) 05252 Murals, Glass, (d) 05253 Murals, Photographic: Kiln Fired, Image Sublimation, (e) 05254 Murals: Stone, Tile, and (f) 05255 Murals, Wall.
- 7. Public Speakers: Related to the existing exemption for public speakers (96161 Public Speaking Services), NIGP Code 97258 Visiting Speakers has been added to the NIGP Code Exempt List as an addition9al coding option for higher education institutions. As NIGP Code 97258 is part of the 3-Digit Class Code 972 "Research and Educational Services, Higher Education", this code should only be used by the University System of Georgia (USG) and the Technical College System of Georgia (TCSG).
- 8. **Foreign Visa Processing Fees.** Related to faculty, student and state employee international travel requiring payment of processing fees by foreign government or authorized third parties providing visa services, the NIGP Code 94991 Visa Processing Fees has been added to the NIGP Code Exempt List. As NIGP Code 94991 is part of the 3-Digit Class Code 949 "Financial Services, Higher Education", this code should only be used by USG and TCSG.
- 9. Purchasing Advertising Space. Select exemptions within NIGP Class Code 915 have been revised to clarify the exemption for purchase of advertising space only. For example, the use of outdoor billboards, radio broadcasting, television broadcasting, newspaper advertising, skywriting, etc. to share information is recognized as exempt. An explanatory note has been added to the NIGP Code Exempt List to provide further guidance. In addition, NIGP Code 91510 Advertising, Digital (ad placement only) has been added. Please note that design/creative services, including but not limited to graphic design, brand identity design, web design, etc. are not exempt from competitive bidding rules.
- 10. Inactive NIGP Codes. All references to inactive codes have been removed from the NIGP Code Exempt List. NIGP Code 31243 Environmental Control Systems, Spacecraft was added to the NIGP Code Exempt List to replace inactive code 80440 Environmental Control Systems, Spacecraft. NIGP Code 90779 Survey Services (Not Aerial or Research) was removed due to being inactive; however, state entities may use NIGP Code 92586 Survey Services, Land, which is already included on the NIGP Code Exempt List.

**COMPLIANCE REMINDER:** All purchase orders (POs) for exempt purchases must be coded as EXM. When applicable, the buyer should reference the applicable commodity or service code from the NIGP Code Exempt List. If there is not an applicable code, then the buyer must include an explanation in the comments field of the PO explaining why the purchase is exempt.
